- 2. Board resolution concerning the establishment of business in DGDP Free Zone
- 3. Copy of the passport and resume of the designated manager of the business setup in Dubai Gold and Diamond Park
- 4. Memorandum of Association
- 5. Article of Association
- 6. Rent/ lease agreement of the Retail office and commercial centre.
- 7. Company license and business registration documents of the parent company, in the case of a branch office or representative office



Permitted Activities in DGDP

All of the legal activities related to gold, diamond and other precious metals could be pursued in DGDP.
