CHOOSE YOUR LICENSE TYPE

DAFZA offers six type of Licenses

Trade License:

This type of License allows the holder to carry out trading activities, including import, export, re-export, distribution and storage of specific products.

Service License:

This License is suitable for service-oriented businesses. It enables entities to provide the services specified by their License.

Industrial License:

This allows holders to undertake light manufacturing activities, packaging and assembly.

E-commerce License:

With this type of License, holders are entitled to trade of goods and services online.

General Trading License:

This License allows the holder to trade in general activities, including import, export, re-export, storage and distribution.

Dual License with DED*:

This license allows DAFZA registered companies to apply for a DED (Dubai Department of Economic Development) License without the need for physical office space on the mainland. Businesses possessing this license can operate out of DAFZA.
